### **4 Apprenticeship Positions**

Biology Apprentices (2 positions): build skills in biological monitoring, habitat restoration and enhancement planning and implementation, visitor engagement, and balancing needs of wildlife and visitors.



Visitor Services Apprentice: help increase visitor trips to and experiences on the Refuge through strategic communications and marketing, develop messaging and graphic layout for enhanced signage, and support a multi-dimensional visitor services team.

Community Outreach Apprentice: develop and present engaging outreach programs to urban and suburban youth and families on the Refuge and in the community, develop new partnerships to reach urban youth, and attend community events and festivals to engage urban audiences in nature-based activities.

### **Conservation Biology Apprentices**

2-YEAR Professional Development Opportunity at Minnesota Valley National Wildlife Refuge

### **Position Description:**

The Minnesota Valley National Wildlife Refuge Trust, Inc. (MVT) is hiring two full-time, two-year paid Conservation Biology Apprentices on the Minnesota Valley National Wildlife Refuge (Refuge) and Wetland Management District (WMD). Working in partnership with the U.S. Fish and Wildlife Service (USFWS), these apprenticeships reflect our shared commitment to mentor the next generation of conservation professionals.

The Refuge is located in the Minneapolis/St. Paul metropolitan area and the WMD encompasses a 14-county area both within and outside of the metropolitan area. The Refuge is a haven to bald eagles, river otters, migratory birds and a variety of other wildlife. The WMD manages Waterfowl Production Areas scattered throughout the 14 counties for the benefit of nesting waterfowl and grassland dependent species. The Refuge and WMD collectively manage over 25,000 acres of diverse habitats including wetlands, floodplain and upland forest, oak savanna and prairie in urban, suburban and rural settings.

The Conservation Biology Apprentices will be employees of the Minnesota Valley Trust, a nonprofit conservation organization based in the Twin Cities. Over the two years, the apprentices will work alongside and learn from USFWS professionals what it is like to manage, restore, and protect vital natural resources. They will:

- Conduct plant, invertebrate, and bird surveys in diverse habitats
- Manage invasive species (will include herbicide application)
- Manage and monitor water levels
- Conduct public education and outreach
- Conduct habitat restorations and assessments
- Construct and maintain infrastructure
- Collect, enter and synthesize field data for reports and summaries

These positions include working both indoors in an office and outdoors. Outdoor working conditions may include the following: being outdoors for extended periods of time in all weather conditions, exposure to biting/stinging insects and ticks, exposure to poisonous plants, and hiking over uneven terrain through tall vegetation. The work involves bending and lifting, significant walking and a moderate amount of physical exertion.

- Post-secondary 2 or 4-year education in natural resources (degree obtained or pending)
- Experience with or willingness to learn Midwest plant and animal identification
- Physically fit -- capable of walking long distances and lifting 45 pounds
- Able to work independently and in small groups
- Excellent communication skills (written and verbal)
- Basic computer skills (Microsoft Word, Excel, etc.), data management skills preferred
- Experience with or willingness to learn how to operate and use GPS and GIS technologies, canoes, ATVs, farm equipment, and mowers (please note experiences on resume)
- Valid state driver's license

### **Position Description:**

The Minnesota Valley National Wildlife Refuge Trust, Inc. (MVT) is hiring a full-time, two-year paid Visitor Services Apprentice to join the Visitor Services Team at Minnesota Valley National Wildlife Refuge in Bloomington, Minnesota to support a thriving Urban Refuge where nature connects people, communities, and wildlife.

The Visitor Services Apprentice will be an employee of MVT, a nonprofit conservation organization based in the Twin Cities. Over two years, the apprentice will work alongside and learn from U.S. Fish and Wildlife Service (USFWS) professionals to:

- Assist in production of a variety of strategic communication and marketing tools to engage focus audiences with the Refuge
- Support exhibit work: Design and develop interpretive sign content including writing text and layout design for exhibits and signage at trailheads and in the Refuge visitor centers
- Social Media: Assist with social media campaign management
- Website: Develop content for the Refuge website (training will be provided)
- Publications: Support updating publications and creating materials for public programs and events
- Support visitor center operations to provide Refuge information and deliver nature-based activities to visiting public
- Explore various career paths and network with local employers within the field of natural resource management
- Identify areas for professional growth, develop and complete a training plan that addresses needs

80% of the work will be in the office, while 20% of the work will be in the field and will involve some physical activity, including walking or standing for long periods of time.

### **Position Description:**

The Minnesota Valley National Wildlife Refuge Trust, Inc. (MVT) is hiring a full-time, two-year paid Community Outreach Apprentice to be stationed at the Minnesota Valley National Wildlife Refuge (Refuge) to support the efforts of the Urban Wildlife Conservation Program (UWCP). Minnesota Valley is one of 14 priority urban refuges in the nation. Nestled in the shadows of skyscrapers 14,000 acres of wild space starts just 5 miles from the Mall of America and less than 15 miles from the heart of the Twin Cities (Minneapolis/St. Paul). This special setting provides the Urban Outreach team a unique opportunity to plan nature-based programs, outdoor recreation experiences and environmental career exploration opportunities to communities throughout the Twin Cities.

The Community Outreach Apprentice will be an employee of MVT, a nonprofit conservation organization based in the Twin Cities. Over two years, the apprentice will work alongside and learn from U.S. Fish and Wildlife Service (USFWS) professionals to:

- Assist in developing and presenting engaging outreach programs for youth and families
- Maintain and build new relationships with a diverse set of partners
- Attend community events and festivals with staff and volunteers to provide refuge information and nature-based activities
- Identify and complete a robust project based on personal interests, professional development goals and refuge need
